

## Predict the DHL Fastest Terms and Conditions

### Full Terms and Conditions

1. This Promotion is only open to those aged 18 or over, including employees and customers of the Promoter, however, the Promoter's agents, third parties or any other person professionally connected with the Promotion are not permitted to enter.
2. Entrants must ensure that their participation (including the acceptance of any Prize awarded) is lawful in accordance with the laws of the country of which they are a citizen and/or resides. This Promotion is void where void under local national laws. The Promoter shall not be taken to make any representations, express or implied, as to the lawfulness of any individual's participation, or as to any other aspect of any Promotion.
3. No purchase is necessary; however, internet access is required. Participants are reminded to get the owner's permission before using a computer, device and/or internet-access which is not owned or paid for by the entrant to enter the Promotion. The Promoter will not be liable for any internet or mobile connection, or other charges incurred in entering the Promotion.
4. **Promotion Period:** Promotion opens at 11:00 CEST 14<sup>th</sup> October 2024 ('Opening Date') and closes at 13:00 CET 8<sup>th</sup> December 2024 ('Closing Date').

There are 6 individual Grands Prix ('**Race**') within the Promotion Period. Each individual Race opening time and date ('**Race Opening Date**'), and closing time and date ('**Race Closing Date**') are as follows:

**United States Formula One Grand Prix:** Opens at 11:00 CEST on 14<sup>th</sup> October 2024 and closes at 20:00 CEST on 20<sup>th</sup> October 2024.

**Mexico Formula One Grand Prix:** Opens at 11:00 CEST on 21<sup>st</sup> October 2024 and closes at 20:00 CET on 27<sup>th</sup> October 2024.

**Brazilian Formula One Grand Prix:** Opens at 11:00 CET on 28<sup>th</sup> October 2024 and closes at 17:00 CET on 3<sup>rd</sup> November 2024

**Las Vegas Formula One Grand Prix:** Opens at 11:00 CET on 4<sup>th</sup> November 2024 and closes at 06:00 CET on 24<sup>th</sup> November 2024

**Qatar Formula One Grand Prix:** Opens at 11:00 CET on 11<sup>th</sup> November 2024 and closes at 16:00 CET on 1<sup>st</sup> December 2024

**Abu Dhabi Formula One Grand Prix:** Opens at 11:00 CET on 2<sup>nd</sup> December 2024 and closes at 13:00 CET on 8<sup>th</sup> December 2024

**Please note that the above Race Closing Dates are one hour before the applicable Race starting time.**

#### **5. To Enter:**

a. Log into your DHL InMotion account or set up a DHL InMotion account:

<https://inmotion.dhl/en/user/login>. The required details are as follows:

- Email address
- First name
- Last name
- Country
- Date of birth

b. Go to <https://inmotion.dhl/formula-1/predict-the-fastest> to participate in the Promotion.

c. By the individual Race Closing Date complete the following:

**i. Predict the time for the DHL Fastest Lap and the driver ('FL')**

**ii. Predict the time for the DHL Fastest Pit Stop and the team ('FPS')**

c. Entries that are not made within the applicable opening and closing dates and times, are not complete, or do not adhere to the Terms and Conditions will be disqualified at the sole discretion of the Promoter.

d. Only one entry per person per Race (predicting both the fastest lap and fastest pit stop equals one entry).

e. Once a prediction has been made, it cannot be amended, changed, or deleted.

f. You may not enter more than once by using multiple accounts, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your entry will be disqualified at the sole discretion of the Promoter.

g. All entries must be received by each individual Race Closing Date to be valid, and no liability is accepted for incomplete or late entries.

#### **6. Individual Race winner selection and notification:**

a. There will be two winners per Race (**'Individual Winner'**): there is one Individual Winner per FL per Race and one Individual Winner per FPS per Race (12 winners in total during the Promotion Period).

b. The Individual Winner of the FL is the entrant who correctly predicted the driver and placed the closest prediction to the actual FL time for the applicable Race.

- c. The Individual Winner of the FPS is the entrant who correctly predicted the team and placed the closest prediction to the actual FPS time for the applicable Race.
- d. In the event of a draw for first place, all entrants with the same score will be placed into a random prize draw and selected by a random generator. The first entrant drawn will be awarded the Prize.
- e. Winners will be notified via email by a third-party representative via their InMotion account email address within 14 working days of the Race Closing Date. The Promoter shall have no liability for a winner's failure to receive notices due to the notification landing in the winner's spam, junk e-mail, or blocks from other security settings, or for the winner's provision of incorrect or otherwise non-functioning contact information.
- f. If a winner cannot be contacted, is ineligible or fails to claim the Prize within 14 days from the time the original winner notification was sent, despite multiple contact attempts, the Prize may be forfeited, and the Prize awarded to the next ranked entrant.

- e. The winners will be responsible for any tax liability and customs as relevant with national laws dependant on their country of residence.

**8. Overall season winner selection and notification:**

- a. All entrants will be ranked on a real-time leaderboard on InMotion for both FL and FPS across the Promotion Period.

- b. Entrants are scored and ranked by the time difference between their prediction and the actual time for FL and by the time difference between their prediction and the actual time for FPS.
- c. Entrants who do not predict for a Race are penalised with a time addition of 1 second per missed FPS per Race and 5 seconds per missed FL per Race.
- d. There are two overall season winners (**'Season Winners'**): The entrant with the lowest FPS leaderboard score at the end of the Promotion Period and the entrant with the lowest FL leaderboard score.
- e. In the event of a draw for first place, all entrants with the same score will be placed into a random prize draw and selected by a random generator. The first entrant drawn will be awarded the Prize.
- f. Winners will be notified via email by a third-party representative via their InMotion account email address within 14 working days of the Race Closing Date. The Promoter shall have no liability for a winner's failure to receive notices due to the notification landing in the winner's spam, junk e-mail, or blocks from other security settings, or for winner's provision of incorrect or otherwise non-functioning contact information.

- a. The FL Season Winner will receive a clock made up of an authentic race-used part, or an element that was used in a previous season's race. No choice of part, element, or race.
- b. The FPS Season Winner will win one square of a 2025 race day F1® Chequered Flag (no choice of race). The winner's name will be added to a one square of the flag and the winner will receive the piece of the flag in a frame following the race. The square comes with a certificate of authenticity.
- c. The Prizes are non-transferable, are not exchangeable and have no cash or other alternative in whole or in part.

- d. The Promoter reserves the right to offer an alternative Prize, of equal or greater value, should the advertised Prize become unavailable for reasons beyond their control.
- e. The FL Season Winner Prize will be delivered to the winner within 28 days of Prize acceptance. The FPS Season Winner Prize will be delivered to the winner in 2025 subject to the date of the inclusion of the flag in a 2025 race. The Promoter cannot accept any responsibility for delays in shipping for Prizes due to factors outside of their control.
- f. The winners will be responsible for any tax liability and customs as relevant with national laws dependant on their country of residence.

## **10: General**

- a. All personal data will be held in accordance with all relevant data protection legislation currently in force.
